sent an e-mail stating that they have no other additional information except what has been stated in the original complaint dated 15.1.22 submitted to National Human Rights Commission.

In view of the materials available in the complaint, the Commission passed an order directing DGP, Tripura to inquire into the matter and submit report to the Commission.

Pursuant to the order of the Commission, DGP, Tripura submitted report stating that a written complaint was lodged by Shri Angel Reang to NCC PS, as such Case No:2022NCCP007 dated 16.1.22 Under Section 325/34 IPC and Section 3 of SC/ST Prevention of Atrocities Act,1989 has been registered against traffic personnel namely: Kishore Banik and 2 (two) others. It is also reported that after completion of investigation the case has ended in final report as mistake of fact and referred to Supervising Officer for approval.

The DGP, Tripura also has reported that a counter case vide NCC PS Case No: 2022NCC005 dated 13.01.2022 Under Section 353/332 of IPC has been registered against the complainant of NCC PS Case No: 2022NCC007 dated 16.01.2022. It is further reported by DGP, Tripura that the counter case, on investigation has also ended in final report as mistake of fact vide NCC PS FR (MF) No.78 of 2022 dated 10.11.2022.
