The report of the Commissioner is silent in respect of recovery of PF dues and credit of the said amount to the workers' PF account for the period from November 2008 to June 2018 i.e for recovery of PF dues Rs. 15,98,181/- + 42,27,937/- = 58,26,118/- . Almost five years are going to expire and no action is taken till today.

As such the Commission is not satisfied about the report of the PF Commissioner for recovery of the above amount of Rs. 5826118/- and so PF Commissioner is directed to submit report about the specific action taken in this regard. PF Commissioner is also directed to inform what are the prescribed legal action as per law and the action taken by the PF Commissioner, if any, in this regard.

The PF Commissioner is also to inform the action taken against the establishment for recovery of Rs. 52,36,377 for the period from July 2018 to march 2021.

The Commission vide order dated 01.04.2023 directed Secretary and Labour Commissioner, Labour Department, Govt. of Tripura to submit report clarifying some points and accordingly notice was issued.

The Secretary to the Govt. of Tripura vide letter No. F.90 (30) – LAB / PL / TEA / 2023 / 1592-93 dated 30.03.2023 submitted his report. It appears from his letter that no report is submitted as per Commission's requirement vide order dated 01.04.2023 and so the report is not satisfactory. In fact the Secretary and Labour Commissioner chosen to remain silent to the queries of the Commission.
