01	20.10.2023	<p>Received a communication from the Superintendent of Kendriya Sansodhanagar, Bishalgarh vide No. F.II-3/KST/BLG/UTP/2023/20225 & 20226 dated 19.10.2023, addressed to the Assistant Registrar (Law), NHRC, New Delhi and the Chairperson, Tripura Human Rights Commission, Agartala in which it is reported that one U.T. prisoner, namely, Md. Billal Shekh, S/O. Md. Paichak Sikder of Jugania, P.S. Norakachi, Norail, Bangladesh in connection with DMN P.S. Case No.112/2023, U/S. 3 of I. P. P. Act was admitted at AGMC & GBP Hospital, Agartala directly from Dharmanagar on 30.08.2023 and on 12.09.2023 he was discharged from AGMC & GBP Hospital and admitted to Kendriya Sansodhanagar, Bishalgarh, Tripura.</p>	



Thereafter on 16.09.2023 again he was sent to Atal Bihari Vajpayee Regional Cancer Centre, Agartala as per advice of the M.O., KST Hospital and as per advice of the doctor of Atal Bihari Vajpayee Regional Cancer Centre, Agartala he was admitted there on that day at about 12.30 pm for his better treatment. But on 19.10.2023 at about 05.15 am the said U.T. prisoner, Md. Billal Shekh was expired during his medical treatment at Atal Bihari Vajpayee Regional Cancer Centre, Agartala.

Since it is a death while a prisoner was in custody, it is the duty of the Commission to see the cause of death and the circumstances under which the death has occurred. Accordingly, cognizance is taken on the basis of the papers placed before the Commission for further course of action.

IG, Prisons is, therefore, directed to furnish the following information in respect of death of U.T. Prisoner, Md. Billal Shekh, to this Commission.

- (i) To submit a detailed report covering all aspects leading to death of prisoner.



- (ii) Initial health screening report of the prisoner for the period under custody.
- (iii) Complete medical treatment report for the period of custody including treatment given as indoor patient.
- (iv) Inquest report.
- (v) Post mortem examination report.
- (vi) Videography of post mortem examination.
- (vii) Chemical examination report of viscera.
- (viii) Report with final cause of death based on scientific report.
- (ix) Magisterial inquiry report in details of the UD case.

The report should be sent to the Commission within 04 (four) weeks from today.
