better treatment. Thereafter the said R.I. convict was referred to AGMC & GBP Hospital, Agartala by the Medical Officer of Bishalgarh Sub-Divisional Hospital for his better treatment. Later on, on 31.12.2023 at about 12.57 pm the Medical Officer of AGMC & GBP Hospital, Agartala declared the convict patient as brought dead. The death information of said deceased convict was communicated to the family members through Office Crash Massage.

Since it is a death while a convict prisoner was in custody, it is the duty of the Commission to see the cause of death and the circumstances under which the death had occurred. Accordingly, cognizance is taken on the basis of the papers placed before the Commission for further course of action.

The Inspector General of Prisons is, therefore, directed to furnish the following information in respect of death of Convict Prisoner, Prangopal Roy, to this Commission.

- (i) To submit a detailed report covering all aspects leading to death of prisoner.
- (ii) Initial health screening report of the prisoner for the period under custody.

- Complete medical treatment report for the (iii) period of custody including treatment given as indoor patient.
- Inquest report. (iv)
- Post mortem examination report. (v)
- Videography of post mortem examination. (vi)
- Chemical examination report of viscera. (vii)
- Report with final cause of death based on (viii) scientific report.
- Magisterial inquiry report in details of the (ix) UD case.
