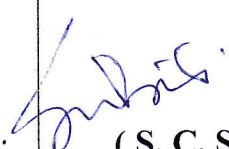
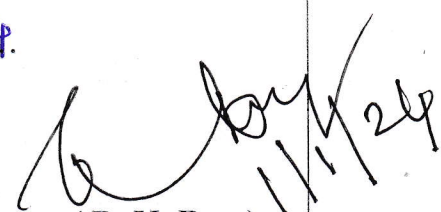

01	01.01.2024	Received a communication from the Superintendent of Kendriya Sansodhanagar, Bishalgarh vide No. F.II-3/KST/BLG/CON/2023/23147 dated 31.12.2023, addressed to the Assistant Registrar (Law), NHRC, New Delhi and the Chairperson, Tripura Human Rights Commission, Agartala in which it is reported that one convict prisoner, namely, Prangopal Roy, S/O. Late Mathura Mohan Roy of Joynagar, P.S. Jirania, West Tripura, convicted in connection with Case No.ST 32(WT/A) 2001, U/S. 302 of IPC to suffer R.I. for life as per order of the learned Sessions Judge, West Tripura, Agartala. The said R.I. convict patient was referred to Bishalgarh Sub-Divisional Hospital on 31.12.2023 at 12.00 pm as per advise of Medical Officer of Kendriya Sansodhanagar Hospital, Bishalgarh for his	

	better treatment. Thereafter the said R.I. convict was referred to AGMC & GBP Hospital, Agartala by the Medical Officer of Bishalgarh Sub-Divisional Hospital for his better treatment. Later on, on 31.12.2023 at about 12.57 pm the Medical Officer of AGMC & GBP Hospital, Agartala declared the convict patient as brought dead. The death information of said deceased convict was communicated to the family members through Office Crash Massage.

Since it is a death while a convict prisoner was in custody, it is the duty of the Commission to see the cause of death and the circumstances under which the death had occurred. Accordingly, cognizance is taken on the basis of the papers placed before the Commission for further course of action.

The Inspector General of Prisons is, therefore, directed to furnish the following information in respect of death of Convict Prisoner, Prangopal Roy, to this Commission.

- (i) To submit a detailed report covering all aspects leading to death of prisoner.
- (ii) Initial health screening report of the prisoner for the period under custody.
