		Purba Paul of Agartala Circuit House area was admitted	
		in the hospital for delivery and on 23/11/2023 the

		taken to the ICU, nothing was explained to the patient	
	-	party. However, the patient party, considering	*
		the life of the patient agreed to the proposal of the	
		hospital and accordingly Purba Paul was shifted to the	No. of the control of
	2 6	ICU. After a few days the patient party was informed	
		that she has to be taken to ventilation for her quick	
	a a	recovery. The patient party used to visit the hospital and	
		they were allowed to see the patient from a distance and	
	9	they allegedly found the patient was kept in a glass box	
		and some time they found body movement of the	
		patient. The hospital authority kept the patient for a	
		continuous period in ventilation without informing the	
		patient party about the actual physical condition of the	
		patient. Later on, the patient party observed that there	
		was no movement in the patient's body, but still the	No. of the Control of
		patient was kept in the ventilation. On last Friday, the	

patient parties were informed that Purba Paul has expired. When the family members of the patient demanded the dead body, the hospital authority handed over a bill of more than Rs. 17(seventeen) lakh and on that issue there were huge tension and excitement for which Police was informed and after arrival of Police, the hospital authority handed over the dead body to the patient party. It is stated in the news item that information as to what amount had to be paid could not be ascertained. There are so many other general allegations against the hospital authority.

Be that as it may, a hospital is considered to be a place of faith and trust. It is expected that a human being while in serious physical ailment goes to hospital for recovery with a faith on the hospital authority and the Doctors as representative of God. If nothing was informed to the patient party about the seriousness of the patient and continued to keep the patient in the ventilation or ICU, it will definitely come under the purview of violation of Human Rights.

We therefore consider to take cognizance on the basis of the newspaper reports and direct the ILS hospital authority, Agartala to submit a report in writing in respect of the allegations reported in the news items before the next date.

We further consider to direct the Director General of Police (DGP), Tripura to inquire/investigate into the allegation through responsible senior officers according to the wisdom of the DGP and to submit a report before the commission before the next date.

We also consider to direct the Secretary, Health and Family Welfare Department, Govt. of Tripura to initiate an effective inquiry through responsible officers/doctors under the Health Department of the state govt. to inquire into the matter and to submit a report before the commission before the next day.
