Niyamul Mullah dated 24.03.2023 was placed before NHRC on 19.04.2023 and NHRC has passed an order which has been communicated to D.M, West Tripura and others including Secretary THRC.

Since, THRC has already taken cognizance of the matter by order dated 24.03.2023 itself, the information be communicated to the Deputy Registrar (Law) M-2 Section of NHRC immediately.
