At the same time, he also admits that he received the Gratuity of Rs. 7,50,000/- (Rupees Seven lakhs Fifty thousand) on 29.08.2022, Leave salary of Rs. 11,10,240/- (Rupees Eleven lakhs Ten thousand Two hundred Forty) on 08.09.2022, GPF final withdrawal of Rs. 1,05,607/- (Rupees One lakh Five thousand Six hundred Seven) on 03.11.2022 and Group Insurance of Rs. 1,06,279/- (Rupees One lakh Six hundred Two hundred Seventy Nine) on 20.12.2022.

In respect of his two grievances stated above, we are to take the opinion of the Respondent i.e. the General Manager (Tech) of TSECL, Agartala.

It also appears from the report submitted by the Respondent that the petitioner was an employee of the Department of Power, Government of Tripura and since 01.01.2005 Shri Bhattacharjee was deputed to TSECL and performed his duties till the date of his retirement on deputation. So the pensionery benefit and other

benefits had to be released / extended in favour of Mr.

Bhattacharjee at the time of his retirement by the

Department of Power, Government of Tripura.

We find that the Power Department is a necessary party in this case. Accordingly, the petitioner is asked to take appropriate step in respect of Power Department so that the opinion of the Power Department can be obtained.
