preserved and handed over to I/O for chemical analysis and submission of report to the hospital which is inevitable to submit final PM report.

It is found on records that after the death of Muslim Shiek, GB TOP GD entry no. 03 date 09.01.2023 was made and WSI Amita Tripura of GB TOP conducted the preliminary investigation in respect of the death of Muslim Shiek.

It is not understood why the police officer investigating the U.D. case in connection with the GB TOP GD entry has not yet collected the viscera examination report from SFSL, Narshingarh and not submitting the same to the Medical Superintendent for submission of final PM report.

Papers before us shows that after the death of Muslim Shiek Bishalgarh PS U.D. case no. 2023BLG004 dated 29.01.2023 U/S 174 of Cr.PC was registered.

As it appears, one ASI Pradip Nowatia of Bishalgarh PS reported I.G. Prisons that the viscera were sent to TSFSL, Narshingarh.

Either the report has been collected by the police officer
