		complex. On this issue, a hot altercation took place between	
		the sentry constable, some women staff of R.K. Pur PS,	
		Subrata Das and his wife Kusum Begam. In the meantime	
		O/C R.K. Pur PS also arrived and tried to stop them from

including O/C in most filthy language. Being tempted, the O/C Inspr. Babul Das gave a slap to Subrata Das and there was a scuffing also between his wife Kusum Begam and women staff of R.K. Pur PS. After that SDPO, Udaipur also came to R.K. Pur PS and discussed with Subrata Das, his wife and the police staff involved in the incident. Finally, the issue was sorted out and Subrata Das left PS with his wife. The minor boy whom they brought from Campertilla to R.K Pur PS was handed over by the police to his actual mother Beauti Sarkar W/O Sri Ranjit Sarkar of Durga Chowmuhani under Kakraban PS.

On the basis inquiry report of SDPO, O/C Babul Das was immediately closed to office of SP, Gomati and a departmental proceeding has been initiated against him for misconduct.

It appears that action has already been taken by the police authorities against the concerned police officers involved in the incident. As such, the Commission considers it appropriate to dispose of the case and accordingly the same is closed.
