Later on, the said convict patient was admitted to AGMC & GBP Hospital on 24.05.2024 at 11.01 am. Thereafter on 26.05.2024 at about 03.15 am the Medical Officer of AGMC & GBP Hospital, Agartala declared the convict patient as dead. The death information of said deceased convict was communicated to the family members and near relatives through O.C., Ambassa P.S., Dhalai, Tripura.

Since it is a death while a convict prisoner was in custody, it is the duty of the Commission to see the cause of death and the circumstances under which the death had occurred. Accordingly, cognizance is taken on the basis of the papers placed before the Commission for further course of action.
