		It is stated in the report that Raghu Sarkar, father of the	E.
		complainant Smt. Shiuli Sarkar was a Class IV employee of the	
		TSCCF Ltd. and he expired on 13/07/2014, while in service. In	
		terms of Govt. of Tripura, GA (P&T) Department Notification,	
		dated 02/03/2019, a survivor/legal heir of a deceased public	
		servant was entitled to a job under die-in-harness scheme or a cash	
		benefit, as per the terms & conditions formulated by the	
		government. It is stated in the report that the complainant	
		submitted an application for the job, but it was after a long delay,	
		however, the respondent, i.e. the TSCCF Ltd. is ready to disburse	
		Rs. 1,00,000/- (one lakh) to the complainant Shiuli Sarkar as per	
		the scheme. The complainant also in her written response has	
		stated that she is ready to receive Rs. one lakh instead of a job	
		under the die-in-harness scheme.	2
	- -	It is an undisputed position that the complainant Shiuli	
		Sarkar is an unmarried daughter of the deceased employee Raghu	
	<i>a</i>	Sarkar and Raghu Sarkar died while in service, leaving behind	
	· · · ·	Shiuli and her mother, who were dependent on the salary of Raghu	
		Sarkar. We find in the communication made by the Chief	
		Executive Officer that Raghu Sarkar was already above 50 years of	
		age, so his next kin is not entitled to get a job but is entitled to get	
		a monetary compensation of Rs. one lakh.

Under the above admitted position, we recommend that the Chief Executive Officer, TSCCF Ltd. shall disburse the agreed amount of Rs. one lakh to the complainant Shiuli Sarkar after taking proper document from her and her mother and it should be completed within 30(thirty) days from the date of receipt of the recommendation of the Commission.
