01	18.06.2024	<p>Received a communication from the Superintendent of Kendriya Sansodhanagar, Bishalgarh vide No. F.II-3/KST/BLG/CON/2024/10642 dated 18.06.2024, addressed to the Assistant Registrar (Law), NHRC, New Delhi and the Secretary, Tripura Human Rights Commission, Agartala in which it is reported that one convict prisoner, namely, Sajal Sarkar, S/O. Santosh Sarkar of West Office Tilla, P.S. Bishalgarh, Sepahijala, Tripura, convicted in connection with Case No. ST 17/1986, U/S.302/120(B)/149 of IPC &amp; Section 3 of Explosive Act to suffer R.I. for life as per order of the learned Additional Sessions Judge(Court No.2), West Tripura, Agartala and it is also reported that the said convict patient was sent to Atal Bihari Vajpayee Regional Cancer Centre, Agartala on 14.05.2024 at about 10.00 am as per advice of Medical Officer in charge of Kendriya Sansodhanagar Hospital, Bishalgarh for his better treatment. Thereafter the attending Medical Officer of ABP RCC, Agartala examined the said convict patient and admitted him to ABP RCC, Agartala on the same day.</p>	

On 18.06.2024 at about 03.30 am the said patient R.I. convict, Sajal Sarkar has expired at ABP RCC, Agartala during his treatment period as declared by the Medical Officer of ABP RCC, Agartala.

The death information of said deceased convict was communicated to the family members and near relatives through O.C., Bishalgarh P.S., Sepahijala, Tripura as well as to receive the dead body.

Since it is a death while a convict prisoner was in custody, it is the duty of the Commission to see the cause of death and the circumstances under which the death had occurred. Accordingly, cognizance is taken on the basis of the papers placed before the Commission for further course of action.


The Inspector General of Prisons is, therefore, directed to furnish the following information/report in respect of death of Convict Prisoner, Sajal Sarkar, to this Commission:-


- (i) Submit a detailed report covering all aspects leading to death of prisoner.
- (ii) Initial health screening report of the prisoner for the period under custody.
- (iii) Complete medical treatment report for the period of custody including treatment given as indoor patient.
- (iv) Inquest report.
- (v) Post mortem examination report.


- (vi) Videography of post mortem examination.
- (vii) Chemical examination report of viscera.
- (viii) P.M. Report with final cause of death based on scientific report.
- (ix) Magisterial inquiry report conducted in connection with the case.
- (x) U.D. case final Report.

The reports should be sent to the Commission within 04 (four) weeks from today.
