


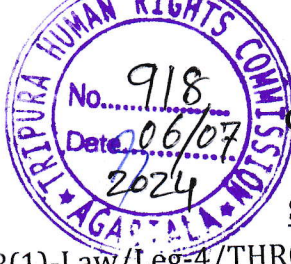

ORDER

Whereas, Dr. H.C. Dsouza was appointed as a Member of the Police Accountability Commission under Section 60 (c) of the Tripura Police Act, 2007, vide notification dated 03-08-2023;

And

Whereas, a complaint (Complaint No. 91 of 2023) was lodged to Tripura Human Rights Commission against Dr. H.C. Dsouza by Shri Dipak Lal Dhar, Resident of Village - Arjya Samaj, near Belonia English Medium School, Belonia, South Tripura District alleging serious misconduct and/or behaviour, including illegal demands related to official matters;

And

Whereas, the Tripura Human Rights Commission (THRC) conducted an inquiry into the mentioned complaint, wherein it found merit in the allegations against Dr. Dsouza and a case of moral turpitude and issued its final order on 17.01.2024, finding Dr. H.C. Dsouza guilty of proven misconduct;

And

Whereas, the Tripura Human Rights Commission in its final order dated 17/01/2024 has given decision / recommendations for taking action against said Dr. Dsouza, after its observation that Dr. Dsouza has grossly misused her official position and act of Dr. Dsouza amounts to a case of moral turpitude;

And

Whereas, every proceeding before the Human Rights Commission shall be deemed to be a judicial proceeding under section 13 of the Protection of Human Rights Act, 1993;

And

Whereas, in adherence to the principles of natural justice, Dr. H.C. Dsouza was duly served with show cause notice, vide No.F.13(71-17)-PD/03/Vol-IK/Shadow/Loose/1472 dated 22/05/2024 giving her an opportunity to respond to the allegations and the findings of the THRC and the reply received from Dr. Dsouza, vide letter no. Nil dated 27/05/2024 against the said show cause notice was carefully considered alongside the findings of the THRC and the legal opinion of the Department;

And

Whereas, it is found upon careful consideration of Dr. H.C. Dsouza's reply to the show cause notice does not satisfactorily refute the allegations of proven misconduct and it is evident that the actions of Dr. H.C. Dsouza, as a public servant, constitute a grave misconduct and breach of duty as outlined in the final order of the THRC;

And

Whereas, with considerable deliberation and in the interest of upholding public trust and integrity, the State Government has decided to remove said Dr. Dsouza as a Member of the Police Accountability Commission, Tripura;

And

Now, therefore, in exercise of the powers under Section 63 of the Tripura Police Act, 2007, and in light of the findings and recommendations of the Tripura Human Rights Commission, the Governor of Tripura is pleased to direct /order of removal of Dr. H.C. Dsouza from the office of the Member, Tripura Police Accountability Commission with immediate effect. Hence, said Dr. H.C. Dsouza is stood released from the said office forthwith on the day she receives this order. Dr. H.C. Dsouza is directed to hand over all official responsibilities, documents, and properties of the Commission in her possession to the competent authority without delay.
