with the miscreants who indulge in such activities of taking law in hand for their whims and caprice and thereby let loose violence like medieval era.

It is reported in the news items that a person named Parameswar Reang of Gandacharra died due to an accident and when the report of his death reached Gandacharra, a group of miscreants let loose the reign of terror at Gandacharra Sub-Division market, Narayanpur Chowmuhani Bazar, village market etc. and they have indiscriminately looted the houses, ransacked the household articles and set on fire the houses of some particular community people and as a result, the innocent villagers, to save their lives have taken shelter inside the forest. It is also reported that victim people are extremely terrorized and are not in a position to resettle them.

Before initiating a formal inquiry, the Commission likes to ask for a report from the DGP, Tripura, as to what action has been taken by the law enforcing agency to nab the offenders of such ghastly offences and whether any criminal case has been registered, and if so, under what penal sections and whether any miscreant has been arrested in connection with the alleged offence.



The District Magistrate, Dhalai District is directed to inquire into the incident through the civil agency and to submit a report as to what sorts of action has been taken to rehabilitate the victims and to settle them in the same position before the alleged incident. How many families were affected and how many houses were gutted and looted should be specified.

Inaction or negligence on the part of public servants in preventing the commission of violation of human rights is/are also actionable and, therefore, the notices are issued to submit the preliminary report within three weeks for further course of action.

Issue the notices accordingly.
