dates for payment and did not pay and failed to make payment. Even in different occasion Sri Ghosh threatened him to implicate in false cases.

On 19th July, 2024 complainant lodged a complaint to the Officer-in-Charge, A.D. Nagar P.S. on receiving his complaint also visited his house. Neighboring people also gathered and there the tenant was asked to vacate the room, then Sri Ghosh complained that the owner complainant had raped his daughter.

On 10th August, 2024, police detained him at about 4.00 pm and thereafter at police station three police officer assaulted him and pressed him to admit that he committed rape. The complainant refused. There again they threatened him. Even then the complainant did not admit his guilt as he did not commit the offence. The complainant demanded for

his medical examination. But police officer did not listen anything. In the night at 8.00 pm, he noticed that some people attended the Police Station and one more police officer also arrived. That officer also demanded his confession of guilt. The complaint urged for his medical examination in case of necessity. But that officer also did not listen him. At that time some media personnel came there and police personal lined up some persons and complainant was forced to line up among them. Media personals took photograph of the lined-up persons including complainant.

On 11th August, 2024 in 'Pratibadi Kalam' Newspaper, one news item was published under the heading 'Atak Neshay Ashakta 52 Jan' and other news item was published in 'Planet East' newspaper under the heading "52 suspected drug users detained". In both the newspapers amongst the drug addicted

persons photograph of the complainant was also published.

Complainant claimed that he was not an addicted person but A.D. Nagar Police Station showed him as drug addict and drug user. He is a disabled person and as such he sympathy to some used neighborers. Due to publication of the news involving his photograph as drug addict and drug user, his reputation has been signed in the estimation of people around him. Now everybody uses to avoid him and officer asked him whether he is addicted to drug. He felt depressed and helpless. His right to live with dignity is thus seriously affected due to action of A.D. Nagar Police Station and thus he prayed for taking action against the involved police officers of A.D. Nagar and to confirm his human right to lead a life with dignity.

The complaint shows serious allegations of violation of human right of the complainant. Hence this Commission has taken cognizance of the incident.

Send a copy of his complain along with enclosed documents to the Superintendent of Police, West through DGP, Tripura with direction to inquire into the matter and to submit his response on the allegation of the complainant within three weeks from the date of receipt of this order.
