"The matter was enquired into and a detailed report has been furnished by the Superintendent of Police (West), Tripura, Agartala. It is revealed that on 04/07/2024 at about 1330 hrs information was received regarding an unlawful gathering in front of Shiksha Bhawan. Acting on this information, some officers from West Agartala PS along with TSR, CRPF and female staff rushed to the location. A total of 31 supporters of the Students Federation of India (SFI) had congregated in front of Shiksha Bhawan. The Director, Higher Education, Shiksha Bhawan confirmed that he had no knowledge of the gathering. The police officers attempted to communicate with the leaders of SFI present at the place but the SFI supporters refused to heed to the instructions of the Police. Shouting slogans, they tried to enter into the premises of Shiksha Bhawan forcibly. They also obstructed the office lane and adjacent road for approximately two hours.

On account of non-compliance of Police directives by the SFI supporters, OC West Agartala PS along with the then SDPO Sadar, DCM from the SDM Sadar Office and a Woman Inspector of West Agartala PS further requested the SFI supporters to vacate the road but they did not co-operate. Subsequently, SFI supporter Sri Sandipan Deb along with 30(thirty) others were detained/arrested and taken into Police custody at the A.D. Nagar temporary detention centre by a Police bus.

18/9/20 Sozia It is pertinent to mention here that during the detention/arrest, no individuals sustained injuries nor did any of the SFI supporters report any grievance regarding the conduct of the police staff. The detained individuals were held at the A.D. Nagar temporary detention centre for approximately two hours and then they were released following necessary orders from the Executive Magistrate. The matter was noted in the GD vide West Agartala PS GDE No. 25 dated 04/07/2024. During the entire incident, Police has taken action as per law".

We have meticulously examined the complaint. The allegations made in the complaint prima facie did not make out a case of violations of human rights. The alleged group of students were in a procession and they were obstructed by the police and had to be arrested because they obstructed the public road and thereafter, all of them were shifted to a Detention Centre and after order of the Magistrate, they were released.

We find no violation of human rights by any police officer or authority. The complaint is therefore disposed in limine. A copy of this order may be published in the Commission's official website.
