Bishal Chakraborty allegedly kidnaped the girl and did not report to the police station. After recovery of the girl, she was handed over to her guardian. Initially guardians of the minor girl were not willing to register any case but after 5(five) days, they submitted FIR before the Kailashahar Women Police Station against Bishal Chakraborty and a specific case registered at Women Police Station as vide case No.2024WKS003 dated 11/01/2024, U/S-417/363(2)(n)/506 of IPC & under Section 04 of PCSO Act - 2012. Investigation was arranged and medical examination of the victim girl was made. Her statement was recorded under Section - 164 Cr.PC. In her judicial statement, Ria stated that she had left her home voluntarily with Bishal Chakraborty with an allegation that she did not want to marry the person with whom her parents fixed here marriage. Investigating officer is taking all efforts to arrest the principal accused person Bishal Chakraborty. CDR of his mother's mobile phone and other family members were analyzed and it revealed that Bishal Chakraborty did not use any mobile. The family members of Bishal Chakraborty were thoroughly interrogated to know where-about of Bishal Chakraborty and raid were also

conducted in the house of Bishal Chakraborty at Pratapgarh, Agartala. After registering of Complaint vide No.24 dated Court 29/01/2024, police came to know that the minor girl Ria Debnath have been missing for 2nd time on and from 25/01/2024. The parents Ria Debnath did not inform police regarding her 2nd missing and as such prompt action could not be taken by police to trace her out or to prevent her movement. Her parents also showed non co-operation and did not respond to police timely and effectively and also did not allow police to publish her photographs to facilitate effective search. The Police is trying to trace out Ria Debnath and in constant touch with her parents but no specific clue has been found so far. After on registration of the Court Complaint bearing No. 2024WKS008 dated 23/02/2024 under Section 366/506/342 of IPC, Bishal's mother and his brother-in-law were arrested for abetting the crime.

However, during their examination those arrestees claimed that they were not in touch with Bishal Chakraborty and did not have any clue about his location. In the reports, it is claimed that the investigation of the case is going on.

Send a copy of the report received from the office the Director General of Police, Tripura to the complainant for his response in respect of that report and fixed the next date after 3(three) weeks.
