01	26.12.2024	<p>Received a complaint from one Jashim Uddin, S/O Md. Abdul Malek of village Khupilong under Killa PS, R.K.Pur, Gomati District, who claims to be the Secretary of Udaipur Press Club. Complaint was received on 24.12.2024 in the evening and that complaint is placed before the Commission today. In this complaint, complainant lodged allegation against one Taiyum Hossain, Assistant Sub-Inspector of Police, Melaghar Police Station wherein, he had alleged inter alia that on 22.12.2024 he was going to Neermahal by riding his car alongwith other Journalists to collect news in respect of Governor's visit at Neermahal and when they reached at Melaghar market, the said Taiyum Hossain, Assistant Sub-Inspector of Police at about 2.25 PM asked him to stop his vehicle and accordingly he stopped. The said ASI told him that he could not move towards Neermahal at that point of time as Governor was visiting Neermahal. Complainant introduced himself to the said ASI and also conveyed that he being a journalist alongwith his other colleagues should go to the Neermahal to cover the news of the Governor visiting Neermahal and at that the said ASI became furious and forced his vehicle with his hand and used slang languages against them. It is alleged that the said ASI uttered un parliamentary words against Journalist Society. Complainant felt that he was wrongfully restrained and he could not proceed towards Neermahal to discharge his professional duty. He alleges that intentionally the said ASI restrained him and obstructed him to</p>	

discharge his professional duty. Facing resistance from the said ASI, he returned from the spot and went to Melaghar Police Station to report the O.C Melaghar but the O.C was not available as such he was waiting for him. By the time the said ASI again reached the Police Station and started to abuse him in slang languages and also threatened him that he would killed him in the P.S complex. The said ASI also advanced to assault him but other police officers resisted the ASI. The complainant became puzzled on the behavior of the ASI. It is further complained that in the Police Station also the said ASI restrained him to divulge the incident to the O.C. Out of fear he left the P.S alongwith his colleagues. The entire matter was recorded in the C.C.T.V footage of the Police Station. Thus, he prayed to take necessary legal action from this Commission. Complainant also reported the incident to the S.P, Sepahijala on 23.12.2024. Complainant annexed a copy of the same alongwith the complainants.


The Commission meticulously perused the complaint. Since there is an allegation of violation of human rights of the complainant as a Journalist, taking cognizance of the matter, The Commission thinks it appropriate to direct DGP, Tripura to inquire into the matter and to submit a report within three weeks.
