		On 12.07.2024 after his death tension gripped	
		several areas of Gandachara. Some of the people by	
		forming themselves into an unlawful assembly,	
		committed a very serious offence of rioting and	
	-	looted the golden ornaments, household utensils,	
		clothes and other things and they targeted the	
1	2	houses and shops and put the houses and shops	

on fire one after the other. As a result, many houses including house of the complainant situated at Haripur 30 Card area at Gandachara were gutted. It is alleged that the police machinery did not take any steps to prevent the riot. After the incident information was given to Gandachara Police Station. Subsequently, police only registered a case.

On 12.07.2024, some local people provoked and instigated the mob against the complainant and others to kill them and on their instigations, the mob became violent and being armed with lathi, dandas, knives etc. they started looting houses, shops and set everything ablaze. Violent mob looted cash to the tune of Rs.2,55,000/-. Besides, golden ornaments all furniture's, complainant valued at Rs.2,65,000/- were looted. They also set fire in his house. As a result some cloths and and household goods, furniture valuable papers were burnt. One inverter and huge stock of shoes were burnt into ashes. He claimed that he suffered a big loss to the tune of Rs. 19,80,000/-.

After the incident, the SDM, Gandachara, Dhalai District fixed compensation only Rs.3,00,000/-which were very poor and unsatisfactory. Being dissatisfied and aggrieved he lodged this complaint before this Commission. Alongwith the complaint he annexed his one prayer

addressed to the SDM, Ganda Twisa, Sub-Division, Gonda Twisa, Dhalai, Tripura and copy of his Aadhar Card.

On perusal of the complaint it appear that the complainant lodged allegation for in action of the police administration to take appropriate step to control the rioting and in adequate compensation in respect of his personal damage.

Since there is an allegation of violation of his human rights to live with dignity, cognizance of this case is taken.

Send a copy of this complaint alongwith enclosures to the DGP, Tripura with direction to inquire into the matter and to submit his report within thirty days also sent a copy of the complaint to the DM & Collector, Dhalai District to submit his response as to the allegation of the complaint within 30 days.

Let the matter be fixed after one month for report of the DGP, Tripura and for response of DM & Collector, Dhalai District.
