		complainant in short is that on 20.12.2024 in	
		between 3.30 to 4.00 AM her sister Smt. Hoimanti	
		Singha was murdered at Melaghar Master Para	
edur And	Section 1	area by pouring inflammatory substance on the	
		body of the deceased.	
	i a	On 27.12.2024 she lodged FIR bearing	
		No.2024/MLG064 in respect of the incident against	
gr. s		Sri Mrinal Kanti Barman and three others. The	
		complainant alleges that the police personnel of	
		Melaghar PS particularly OC Debasish Saha and	
		investigating officer Sri Uttam Paul and one	
		unknown woman constable mentally harassed the	

complainant and the minor daughter Miss Mahasweta Barman of the deceased. It is alleged that at the time of lodging an ejahar the complainant was harassed, humiliated and put on financially losses.

On 20.12.2024 the incident of murder took place and on 25.12.2024 she first went to the PS for lodging the FIR but police misbehaved with her and refused to accept, the FIR and did not take any step. The next date i.e, on 26.12.2024 she again visited PS and prayed for justice, then those police officers without any reasons detained complainant in the PS for the whole day and at the end of the day they informed them that since forensic team did not appear, they could not receive the FIR. Again on 27.12.2024 she went again to the PS to submit her own FIR but police did not receive her FIR but forced her to sign one ejahar which was drafted as desired by the OC of the Melaghar PS and forced the complainant to pay Rs.800/- to the scribe of the ejahar namely Mr. Kamal Laskar. It is alleged that due to misbehavior from police, complainant is feeling unsafe and hopeless and accordingly they bring the matter to this Commission seeking justice by making a prayer that SIT may be formed for speedy and independent investigation and to arrange for immediate arrest of principal accused Mrinal Kanti Barman and to arrange for proper education and

safety of the child of the deceased.

Since, there is a serious allegation of violation of human rights of the complainant by the OC of Melaghar PS namely Debasish Saha and by IO of this case namely Uttam Paul, cognizance of the incident is taken.

Sent the copy of the complaint alongwith all the enclosures to the DGP with a direction to make an inquiry and to report to this Commission by the next date and let the case be fixed after three weeks.
