		It was further mentioned that upon commencement of	

recent Awaasplus survey for PMAY-G 2.0 on January, 2025 block officials from Chandipur R.D.Block visited the residence of the plaintiff and survey was done through mobile app. The enclosed documents i.e. the report of BDO, Chandipur, R.D.Block addressed to District Magistrate & Collector, Unakoti District, Kailashahar gave the following findings:

"1.It is found that Mst. Suhel Begam, D/o- Lt. Moula Miah, is 100% disabled with hearing impairment resides in a kutcha house and did not get any PMAY(G) housing benefit.

2. Mst. Suhel Begam is eligible for PMAY(G) housing benefit but her name was not included in any waiting list as per Annexure-C and Annexure-D.

3. The Permanent Wait List of PMAY(G) is prepared by concerned G.P. and duly approved by the Gram Sabha. Since her name was not passed by the Gram Sabha, so her name was not included in Permanent Wait List of PMAY(G).

4. The In-charge of Samrurpar G.P. is instructed to ensure the enrollment of her name in the priority list in the next PMAY-G survey as per necessary guide lines".

So it appears that the in-charge of Samrurpar GP was instructed to ensure the enrolment of the name of the complainant in the priority list in the next PMAY-G survey as per necessary guidelines.

These being the position, sent the report of the DM & Collector, Unakoti District alongwith the enclosed documents
