		alleged that his son Rahul Acharjee committed suicide on	
		31.01.2025 being failed to bear physical and mental	
		harassment. But police did not arrest the offender and	
		accordingly, he approaches this Commission so that police	
		took initiative to arrest the offenders responsible for the	×
		death of his son. Along with the complaint he enclosed a	
		copy of an information of the death of his son addressed to	
		officer In-charge of NCC PS which was dated 09.02.2025.	
		Subject matter of that enclosed documents was mentioned	
2		as FIR. But in the context there is no specific allegation in	
		respect of any cognizable offence. It appears that the	
		complainant suspected that his son committed suicide due to	а
		some direct inducement and physical and mental torture on	
		his son by one Partha Saha, in whose shop, his son was an	
		employee. The name of the shop was 'Saha	
	1 m	Communication'. It was also mentioned that his son was	
		blamed as 'thief' in respect of cash of that shop and his son	
		was assaulted and also abused and his mobile was forcibly	

taken away by said Partha Saha. As per the contents of that alleged FIR on 31.01.2025 when his son did not return in the house at about 9:30 PM, information was given to NCC PS and on that very date at about 10:50 PM NCC PS received information that in the opposite side of one Shyamalima Apartment beside ILS Hospital dead body of his son was recovered and on information complainant and his wife also rush there and found his son hanging tying with rope and the complainant firmly suspected that his son committed suicide due to torture and false accusation of thief made by Sri Partha Saha.

It was also alleged that in the shop of Partha Saha there are 7/8 CCTV cameras and Sri Saha would try to remove video footages and would also delete the video footage of the mobile of his son. He mentioned the mobile number of his son as 8729882478. It is also mentioned that Partha Saha is a powerful and reach person in the locality. On the other hand complainant belongs to poor section of the society and complainant considers that impartial inquiry /investigation might be hampered and prays before this Commission to ensure impartial investigation in respect of death of the deceased.

Neither the complaint nor the enclosed documents, prima facie, supports the Commission of a cognizable offence. Since it is clear that the dead body was recovered by the NCC PS definitely there will be some entries in NCC PS and the PS might have started an inquiry proceeding to know the actual cause of the death of the deceased.

In view of the allegation of the complainant, before taking cognizance on the matter the Commission considers it appropriate to obtain a report from the DGP, Tripura as to the incident. So the Commission direct the DGP, Tripura to submit a report in respect of death of the son of the complainant and for that purpose the complaint petition along with the enclosed documents shall be sent to the DGP, Tripura.

DGP, Tripura is to complete the investigation and to submit the report within three weeks.

Let the case be fixed after three weeks.
