<b>03</b>	<b>21/02/2025</b>	<p>Today is fixed for report of the DM &amp; Collector, Sepahijala District on the allegation of the complainants Safiqur Rahman and Harun-Al-Rashid of Durgapur, pursuant to the order dated 30/12/2024. Actual date was fixed on 30/01/2025 for that purpose. Since report of the DM &amp; Collector, Sepahijala District was not received on that day, order was passed to issue reminder. Before compliance of this order, report was received from the DM &amp; Collector on 31/01/2025. So, reminder was not issued.</p> <p>Today, I have perused the report of ADM &amp; Collector, Sepahijala District, who submitted the report on behalf of the DM &amp; Collector.</p> <p>As per the report, the matter was inquired by the Tehsilder, Revenue Inspector (R.I.) and DCM, Sonamura Revenue Circle and it was found that Plot No. 2338 of Khatian No. 2/4 of Mouja Nabwadip Chandra Nagar, Tehsil Sonamura was actually a Govt. Khas land belonging to the PWD Department, Tripura and one Md. Samsul Alam, S/o Lt. Ichab Ali of Durgapur was an illegal encroacher of the said land. The Departmental Officer of PWD is the Estate Officer as per Public Premises Eviction of Unauthorized Occupants Act-1982, and the same</p>	

was informed to the Executive Engineer (R&B) PWD, Sonamura Division on 05/11/2024. Another communication was made on 22/01/2025 to the executive Engineer (R&B) PWD, Sonamura Division for providing the action taken information in that connection. The report of the ADM & Collector, Sepahijala District also contains some more documents such as report of DCM, Sonamura Revenue Circle, addressed to the Sub-Divisional Magistrate, Sonamura, report of Tehsilder concerned, addressed to the DCM, Sonamura Revenue Circle, one sketch map of Mouja Nabwadip Chandra Nagar sheet no. 3, as prepared by Tehsilder of Sonamura T.K. and one letter addressed to the SDM, Sonamura by the Revenue Inspector and Tehsilder of Sonamura T.K. and Tehsilder of Khedabari T.K. along with some other documents.

Send the report along with the enclosed documents to the complainants for their written responses, if any.
