		complainant sought for justice and adequate	
		compensation in respect of arson incident	
		occurred in the night of October 6/7 of 2024.	
		It is alleged in the complaint that the said	
		incident occurred during imposition of	
		curfew and deployment of large number of	12
		police force. But the authorities failed to	
		uphold their duty to maintain law and order.	
		During that period, mobs looted shops,	
		homes, stole business goods and set the	
		properties on fire. Shockingly, those crimes	
		took place in presence of senior government	
		officials, including the SDM and SP and large	
		number of armed personnel at Kadamtala	<u>•</u>
		Bazar. No decisive action was taken to stop	
		the violence. That inaction raises serious	
	N.	concerns about law enforcements	
		commitment to protect citizens. The	
		complainant urges the commission to	

investigate the matter thoroughly and hold those officers responsible and accountable.

The complainant claims that he was running two number of mobile and watch shops, one for retail sale and another for wholesale shop under the name 'Khan Mobile & Watch' at Kadamtala bazaar for many years. During the curfew, some miscreants broke into his shops, looted all the goods, and later set the premises on fire. As a result. his entire business. including essential documents, a printer, a banking POS machine, decorations, furniture, bank papers and all stocks were completely destroyed. He has claimed that he sustained total loss approximately Rs.57,52,890/-.

He further claims that he is the sole breadwinner of his family. His six years' old daughter suffers from congenital diseases and all his savings were invested in his business. He had taken a loan of Rs.6,00,000/- from the bank, also borrowed Rs.10,00,000/- from his relatives. He owes Rs.10,70,000/- to suppliers.

Despite his severe financial setback, the State Government has granted him only Rs.50,000/- as compensation, which is grossly inadequate and does not even cover a fraction of his loss. Thus, he prays before the Commission to intervene into the matter and

to ensure fair compensation for his losses.

The perusal of the complaint shows that the shop of the complainant was broken into by some miscreants during imposition of curfew and as such, he was prevented to take adequate measures to stop the arson incident. He also alleges in-action of the Government agencies to protect his shops. Thus, the complaint shows violation of his Human Rights to live with dignity and thus, cognizance of this matter is taken.

Send a copy of the complaint along with all the annexures to the DGP Tripura to enquire into the matter and to submit his report by the next date.

A copy of the complaint along with its annexures shall also be supplied to the DM & Collector, North Tripura for his response, if any, as to the allegation made in the complaint.

The report of the DGP Tripura and response of the DM & Collector, North Tripura should reach to this Commission by the next date.

Fix the next date after 30 days for report of the DGP, Tripura and response of DM & Collector, North Tripura, if any.
