01	16.04.2025	Received a complaint filed by Smt. Paromita Noatia, W/O Diptanil Majumder, D/O Kharindra Noatia of East Side of Old Central Jail, Dhaleshwar under East Agartala PS, having mobile No:7005639322. Gist of the complaint as it appears to this Commission is that on 03.04.2025 at about 10.56 PM the complainant received a mobile call from one Sub-Inspector Sri Dipankar Debnath, having mobile No:940257210 by which said Sri Debnath informed her that a complaint was registered against her and accordingly she informed the matter to her husband. After some time when her husband went out of the room, six individuals including two female constables and a person in civil dress came to their house. The female constables and the person in civil dress were waiting outside of the house. Despite they came	

with female persons, the male officer i.e S.I. Dipankar Debnath and the male person in civil dress entered into her room without being accompanied by any women officers, and the person in civil dress started to interrogate her and also started to accuse her for publishing something defaming a female astrologer and husband of the astrologer using social media platforms like Instagram, Facebook, and Whatsapp. It is alleged that despite there were female officers, in the dead of night, only a male police officer accompanied with a civil person entered into the room of the complainant which is a gross violation of her human life to live with dignity mandated under the law for dealing with women.

The complainant denied all the allegations of publishing anything defaming any astrologer. She complained that when she denied the allegations, the person in civil dress threatened her with dire consequences, invoking political connections and coercing her for admitting the alleged act. Out of fear and for such intimidating situation, the complainant was compelled to make admissions of their allegations.

Subsequently, SI Dipankar Debnath instructed her husband, Mr. Diptanil Majumder, to visit the police station on the following day i.e on

04.04.2025 alongwith the complainant. On 04.04.2025 at around 1:00 PM. her husband accompanied with their Advocate visited to West Agartala Police Station, where they were made to wait for nearly two hours. Thereafter, a police official interacted with them in an extremely rude and threatening manner and pressurized her to make a public apology, though no wrong had been committed by the complainant. The complainant had some CCTV footages in support of visiting those Sub-Inspector and others in their house.

It is alleged that due to grave abuse of power of the police person, the complainant has mentally harassed and her fundamental rights to live with dignity as enshrined in the Article 21 of the Constitution have been violated. Complainant prays to take cognizance of the matter for the violation of her human rights and to take suitable action against the police officer.

✓ Since there is an allegation of visiting the house of the female complainant by a male police officer in the dead of night i.e after sun set and before sun rise without being accompanied by female police officers and compelled her to admit certain actions of social media, the Commission considers it appropriate to take cognizance into the matter.

Send a copy of this complaint alongwith its annexures to DGP, Tripura with a direction to make an inquiry into the matter and submit the report by the next date.

Let the matter be fixed after 30 days for report of the DGP, Tripura.
