		The commission tried its level best to	
		make contact with the complainant.	
		Complainant alleged in the complaint	
		that on 28.01.2025 at about 2/2:30 am, a	
		group of ladies namely Akhlima Begam and	
	-	other five, all of South Ramnagar attacked	
		her 9 years old daughter namely Miss Lovely	
		Begam and mercilessly had beaten her	
	~	making her naked on the main road near	
	1	Sristi Club. It was also alleged that on	
		26/01/2025 at around 2/2.30 am, one Amal	
		Das @ Bikash entered her room and	
A	6	attempted to commit rape on her and	
		outraged her modesty. Since her daughter	

Lovely witnessed the incident and cried loudly, Amar Das @ Bikash became very angry on her and beating over her daughter Lovely was an act of vengeance. As per her intervention, he was not successful in committing rape upon the victim. She also claimed that she visited West Agartala Women P.S, and lodged a written complaint on that very day i.e on 28/01/2025, But the complainant was not entertained by the O/C of the PS. Rather on her last visit to the PS on 02/02/2025 she was advised compromise the matter, as Amal Das @ Bikash Das is a very influential member of the ruling BJP party.

Hence, she lodged a complaint before this commission.

Before taking cognizance on the complaint of the complainant, the Commission considers it appropriate to obtain a report from the DGP, Tripura and the DGP Tripura has submitted his report. Operative portion of the report reads as follows:

From the report of the DGP Tripura, it is clear that no evidence was found to establish that Amal Das @ Bikash, S/o Lt. Rajendra Das of South Ramnagar, attempted to commit rape upon the complainant or outraged the modesty of the complainant



Anuara Khatun and it was revealed that Anuara Khatun also didn't file any complaint either on oral or in writing, at West Agartala PS against Amal Das during her visit to West Agartala Women PS.

Report of the DGP shows that on 28.01.2025 afternoon, Lovely Begam went to the house Rubi Begam for lunch. Some local residents saw her at Rubi Begam's house and they went there and enquired about her mother and they also assaulted her with fists and blows and they told her that like her two sister siblings, they would send her also to home as she had left them alone at home and they were bitten by a dog. Lovely Begam managed to escape from the spot and informed her mother about the incident.

On that day Anuara Begam took her daughter to IGM hospital for medical treatment with the alleged history of assault at around 2:00 pm on the same day. In the prescription dated 28.012025 at about 07:00 pm the attending Medical Officer noted that no external injury/marks were found and advised for X-ray and orthopedic consultation. During inquiry, complainant stated that she didn't follow up suggested X-ray and orthopedic consultation.

During inquiry it appears that the fact

disclosed by Lovely Begam was not true.

Since, the complainant does not appear before this Commission and also doesn't submit her response against report of the DGP Tripura, the Commission considers that the complainant didn't submit her response, since her allegations have got no foundation.

This being the position, this Commission didn't find any violation of her Human Rights by Police i.e, O/C, women P.S. and accordingly, no cognizance can be taken on the allegations of the complaint and the complaint of the complainant is thus, disposed of being devoid of merit.
