03	06.05.25	<p>Today is fixed for report of the DGP, Tripura after making inquiry pursuant to the order dated 12.03.2025. Received a report from the office of the DGP, Tripura submitted by AIGP (Crime) dated 03.04.2025.</p> <p>Perused the report of the DGP, Tripura.</p> <p>The complaint was filed against some police personnel of Kadamtala Police Station alleging refusal of lodging FIR on 19.01.2025 and also against other police official namely: Gayetri Das, W/HC of Kadamtala Police Station. Report of the DGP, Tripura shows that on 20.01.2025 complainant went to Kadamtala PS and reported that on 18.01.2025 at about 2300 hrs her minor daughters namely: Satabdi Debnath and Tanushree Debnath were returning from Pratyekrai Poush Mela. On way the accused (i) Pijush Nath @ Situ S/O Lt. Gopika Nath, (ii) Smt. Anu Nath daughter of Pijush Nath both of Laxminagar, PS Churaibari, (iii) Smt. Anamika Nath D/O Sri Pijush Nath and (iv) Sri Bhajan</p>	

Debnath, driver of e-Rickshaw of Kalikapur, Ps Dharmanagar got down from the e-Rickshaw and wrongfully restrained way of the minor girl and they verbally abused them using slangs and threatened them with dire consequences. They also physically abused and assaulted the girls by fist and blows.

Subsequently on the same date i.e on 20.01.2025 both the parties appeared at Kadamtala PS along with Panchayet members and assured that they would settle the matter amicably among themselves but the matter was not settled. SI, Sanjib Sarkar conducted an inquiry and found that there was previous enmity between the parties and submitted a Prosecution Report against both the parties vide Kadamtala PS P.R No. 58/2025 U/S 126 BNSS on 20.01.2025.

On 22.01.2025, SP, North received a copy of the complaint dated 19.01.2025 from the Smt. Sati Rani Goswami for taking legal action against the accused persons. The complaint was sent to the Officer-in-Charge, Kadamtale PS for taking necessary action with direction to SDPO, Dharmanagar to submit an action taken report on it.

Thereafter, a case was registered vide Kadamtala PS case No.2025KDL011 dated 05.02.2025 U/S 126 (2) / 352/115(2)/76/74/3 (5) of BNS and Section 08 of the POCSO Act, 2012 and investigation of that case is in the final stage.


The allegations that W/HC Gayatri Das had threatened the complainant to withdraw the case and helped the second party members to register a false case against the complainant was totally baseless and false.
