		The complainant's allegation was that his	
		son, Rahul Acharjee committed suicide on

		aged about 21 years, was employed in the shop of	
		one Partha Saha, who was running a mobile shop.

		Saha termed Rahul as a thief. Rahul used to visit	

his house in the afternoon at about 4/5 PM for taking meal. But on that day he didn't come home and his mobile was also shown switched off. Complainant tried to make contact with him for about 30 to 40 times, but failed. Thereafter, they tried to make contact with Partha Saha by visiting his shop and house, but failed to make contact since Partha Saha was not there. At about 09:30PM when Rahul didn't return home, the matter was reported to NCC P.S complainant and on that very day at about 10:50 PM complainant received information from NCC PS that in a construction site situated opposite site of Syamalima Appartment, near ILS Hospital one dead body is found. Then complainant and his wife rushed their and found that his son was hanging tying with rope at his throat.

The complainant believed that his son committed suicide having failed to bear the accusation and torture on his person and said Partha Saha instigated him to commit suicide by making physical and mental assault on Rahul.

Complainant also made an accusation that near the shop of Partha Saha there were 7/8 CCTV Cameras and Sri Saha would try to remove these video footage. The mobile number of his son was 8729882478 and presently that was in the custody of Partha Saha.

Complainant alleged that Partha Saha is a powerful and moneyed person in the locality. On the other hand, the complainant and his family are

very poor and innocent people.

The complainant sought justice to the NCC P.S. But NCC PS did not make any attempt to find out the actual cause of death of his son and also didn't take action against Partha Saha.

In view of the allegation of the complaint, before taking cognizance in the matter, the Commission considered it appropriate to obtain a report from the DGP, Tripura in regard to the incident.

Accordingly, DGP Tripura submitted the report. The report of the DGP Tripura supported the factum of the incident.

The report shows that Sankar Prashad Acharjee, the complainant submitted a written prayer at NCC PS for conducting Postmortem Examination over the dead body of Rahul Acharjee to find out the actual cause of death., and also mentioned that his son worked in the shop of Partha Saha at GB Bazar on monthly payment basis and on 31.01.2025 around 14:00 hours his son Rahul Acharjee left the shop following a quarrel to the shop owner Partha Saha.

Based on that written application an unnatural death case was registered at NCC P.S vide case No.2025NCC012 dated 01.02.2025 u/s-194 BNSS. Postmortem examination over the body of the diseased Rahul Acharjee was conducted at AGMC & GBP hospital. Thereafter dead body was handed over to the complainant.

In the course of investigation, I/O seized the

CCTV DVR from the shop of Partha Saha to find out the actual fact and sent the CCTV DVR to SFSL Tripura for necessary examination and report Postmortem report of the diseased, Rahul Acharjee was collected.

After P.M examination, AGMC & GBP hospital opined that cause of death was asphyxia due to hanging. The viscera was preserved to rule out any concomitant poisoning/intoxication and Viscera sample of deceased is being sent to SFSL Tripura for forensic examination.

Subsequently, on 08.02.2025, the complainant lodged another application to NCC P.S alleging that due to physical and mental torture of Partha Saha, his son committed suicide by hanging and on the basis of that complaint a specific case No.- 2025NCC009 dated 08.02.2025 u/s- 108 BNS was registered. During investigation of the case, the Investigating Officer examined all relevant witnesses and recorded their statements u/s 108 BNSS and also conducted several raids in the house of the FIR named accused namely, Partha Saha. Partha Saha absconded himself to evade police arrest.

However, on 15.02.2025 accused Partha Saha got anticipatory bail from the Ld. Court of Addl. District & Sessions Judge, Court No.2, West Tripura, Agartala. The investigation of the case is going on.

Report of the DGP clearly shows that basing on the complaint of the complainant; NCC P.S has



registered a specific case against Shri Partha Saha, the employer of his son. Subsequently, said Partha Saha obtained anticipatory bail from the court and the entire matter is under investigation. Apparently, the Commission doesn't find that the Police authority was refrained from taking action on the prayer of the complainant.

On perusal of the report of the DGP, Tripura, it is clear that the Commission didn't find any kind of violation of human rights by not taking any appropriate action as per law on the basis of the allegation of the complainant.

So, there is no question of inaction on the part of the O/C, NCC P.S regarding the complaint of the complainant. Investigation of the case is explosively within jurisdiction of NCC P.S and regarding the matter of investigation this commission has nothing to do. The matter may be dealt with by the Competent Criminal Courts. Jurisdiction of this Commission is limited to see whether there was any inaction or over action or biasness by the side of NCC P.S or any other police authorizes relating to that aspect.

The Commission doesn't find any inaction and Commission is satisfied that complaint petition has got no ground. Complainant admitted that his son committed suicide. Whether his son committed suicide due to some inducement or threat that is the subject matter of investigation, which will be looked into by criminal court of competent jurisdiction. This Commission has

nothing to do.

This being the position, this Commission finds no merit in the complaint of the complainant.

Accordingly, the complaint petition is disposed of being devoid of merit.

Inform accordingly to the complainant and the order may be published.
