and monitoring of vitals of the patient was not documented in between 06:00 P.M. on 19/05/2025 to 11:00 P.M. on 20/05/2025.

Thus, from the report, *prima facie*, some negligence is established during treatment. Now it is not disclosed who are the person responsible for not recording and monitoring the physical condition of the victim during that period.

In order to clear up the matter, the Commission thinks it appropriate to direct the investigation team of this Commission to investigate into the matter and to find out the particular names of the persons responsible for not monitoring and documenting the physical condition thereof.

Report of the Investigation Wing should reach to this Commission in 3(three) weeks.
