		It is reported that the landowners of the Jampui Hill is	
		still waiting for compensation for their land acquired more	
		than 7 years ago for highway project by the National	
		Highway & Infrastructure Development Corporation Ltd.	
		(NHIDCL). Despite no dispute or legal hurdles the	
		compensation remains unpaid leaving the affected family in	
		distress and disillusionment. The land was officialyacquired	
		through the process initiated by the Competent Authority for	
	a	Land Acquisition which was Addl. District Magistrate,	
	al a	North Tripura. The notification U/S 3A and 3D of the	
	Marie and the second second	National Highway Act, 1956 were issued of June 25, 2018	
		and February 4, 2019 respectively. The final award	
		determining compensation was a announced on January 19,	
		2021. Even after repeated appeals grievances and official	
		follow up by the affected landowners, NHIDCL has failed	
		to release the compensation. According to the officials	

sources there is no landownership dispute and no legal road block. The Sub-Divisional Magistrate (SDM) of Kanchanpur had already completed the assessment and submitted it to CALA. But NHIDCL as withheld the award payment citing various reasons like changes in project alignment, contractor and a new Detailed Project Report (DPR) in preparation. The news speakeitself.

The Commission finds that the rights of the landowner of Jampui Hill are being violated and they are being harassed and deprived of their legitimate claim which is nothing but violation of their human rights. Accordingly this Commission has taken cognizance of that issue.

Issue notice open the Executive Director, NHIDCL, UD Bhavan, Sukantala Road, Agartala, West Tripura to submit his report in this regard by the next date.

Also issue notice to the LA, Collector, North Tripura, to submit a report as to the news item by the next date.

A copy of this news item be kept with this record and copies of the same also be sent to the NHIDCL and concerned LA, Collector.

Fix the next date after three weeks for report of NHIDCL and LA, Collector, North Tripura.
