Terms & Conditions

- 1. The rate should be quoted for detention Charge @ per day and the running Charge @ per KM as per format as mentioned above.
- 2. The vehicle should be absolutely good and running condition.
- 3. The bidder must submit valid documents like Insurance Certificate of vehicle, Pollution Certificate, Commercial Registration Certificate of vehicle, Road Permit, Vehicle particulars (For Internal Use), 3rd Party Agreement Deed if applicable, self attested copies of NIT, Agency Registration Certificate if applicable, latest IT Returns and GST Registration along with tender/bids.

- 4. Permit of vehicle must be Commercial in nature.
- 5. The vehicle should not older than the model, 2021.
- 6. Providing fuel, lubricants, dusters and maintenance etc for the vehicle will be the responsibility of vehicle supplier/owner.
- 7. The vehicle along with driver should be placed to this Commission within 5 (five) days from the date of receipt of final order.
- 8. The Driver of vehicle should be given prescribed liveries by the supplier/owner of vehicle.
- 9. In case of need, driver of vehicle has to be changed within 24 hours on being informed to this office and if vehicle is not available on any day, no payment (detention charge) would be made for the day and also for the next day.
- 10. In case of repair/maintenance, a similar vehicle shall have to be provided by the supplier/owner in replacement during repair/maintenance periods.
- 11. Payment of hiring charges will be on monthly basis against bill(s) raised by the supplier/owner of vehicle supported by appropriate signature of Log Book from the users.
- 12. Necessary GST/Tax will be deducted from bill(s) as per provision of rules.
- 13. The supplier/owner of vehicle concerned shall arrange Garage of the vehicle locally at his own cost & responsibility.
