03	19/06/2025	<p>Today is fixed for report of the DM & Collector, West Tripura and also for the response of the Chief Managing Director, TSECL, Agartala.</p> <p>Perused the report of the DM & Collector, West Tripura. On 21.05. 2025 this Commission passed some order, the operative portion of that report reads as follows:-</p> <p>“ Received a report from the O/o the DM & Collector, West Tripura by which DM & Collector, West Tripura forwarded a report of Ajay Kumar, Commandant, 42 Bn BSF.</p> <p>The Commission didn't seek for any report from Commandant BSF, 42 Bn.</p> <p>The report of the DM & Collector, West Tripura doesn't show that DM & Collector, is satisfied after making enquiry about the genuineness of the facts as stated by the Commandant, 42 Bn BSF.</p> <p>The DM & Collector, West Tripura is to submit a report after making proper enquiry so that the Commission can trust on his report.</p> <p>Report of the DM & Collector, West Tripura must reach to this Commission by the next date.</p> <p>No report has yet been received from the Chief Managing Director, TSECL, Agartala.</p> <p>The conduct of the Chief Managing Director, TSECL appealed this Commission. The Chief Managing Director, TSECL is not expected to remain silent when his response is sought for.</p> <p>Issue reminder to the Chief Managing Director, TSECL, to submit his response positively by the next date, failing which, no</p>	

further chance will be given to the Chief Managing Director, TSECL and the allegation against the Chief Managing Director, TSECL will be presumed to have been accepted by Chief Managing Director, TSECL.

So, fix the matter after 3(three) weeks for report of the DM & Collector, West Tripura and response of Chief Managing Director, TSECL.”

Today the District Magistrate & Collector, West Tripura, Dr. Vishal Kumar has submitted a report pursuant to the order of this Commission dated 06.05.2025 and 21.05.2025. As per his report the matter was required by the revenue field functionaries under Sub-Divisional Magistrate, Sadar. He perused the same and following findings were given:-

- i. As per instruction of DG (BSF), schedule time of opening and closing Gate No. 98 (Matinagar area) is from 08.00 A.M to 10.00 A.M and from 12.00 P.M to 03.00 P.M daily.
- ii. The BSF people allowed the outside fencing people to carry electronic items as per their household requirements.
- iii. The BSF officials are allowing goods and groceries to the people of outside fencing as per their household requirement.
- iv. Electricity is available to the households of outside fencing.

Thus, it appears that disconnection of electric connections is denied in the report of the District Magistrate & Collector, West Tripura. But no report has been submitted by the Chief Managing Director, TSECL. Despite the previous order giving a last

opportunity to submit response, the Chief Managing Director, TSECL remains silent.

On consideration of the Communication made by District Magistrate & Collector Vide.F.No.10(2-a)/DM/W/JDL/THRC/2022/703 dated 17/05/2025, it appears that the District Magistrate & Collector, West Tripura, has not personally inquired into the subject in issue contained with the complaint. The Commission has taken it as an exception that District Magistrate & Collector, West Tripura made the communication dated 17.06.2025 only on the basis of some reports without any field inquiry. This Commission has subsequently directed the District Magistrate & Collector, West Tripura to inquire into the complaints and issue raised by the complainant.

In view of this, the Commission deems it necessary to visit the area on 01.07.2025 with its investigation team to interact with the complainants to unearth the veracity of the complaints and the communications dated 17.06.2026 made by District Magistrate & Collector, West Tripura.
