Late Babulal Roy of Khejurbagan, Gowalabasti, P.S. NCC, West Tripura was in custody in connection with Case No. NCC PS-34/2025, Under Section 132/324(2)/351(3)/3(5) of BNS as per order of the learned Judicial Magistrate 1st Class, Court No.3,

postmortem examination and also to intimate the death information to the family members and near relatives of the deceased U.T. prisoner, Kailash Roy, with a request to the family members to attend AGMC & GBP Hospital for receiving the dead body after observing necessary formalities.

Since it is a death while a U.T prisoner was in custody, it is the duty of the Commission to see the cause of death and the circumstances under which the death had occurred. Accordingly, cognizance is taken on the basis of the papers placed before the Commission for further course of action.

The Inspector General of Prisons, Tripura is, therefore, directed to furnish the following information in respect of death of U.T Prisoner, Kailash Roy, to this Commission:-

- (i) Submit a detailed report covering all aspects leading to death of prisoner.
- (ii) Initial health screening report of the prisoner for the period under custody.
- (iii) Complete medical treatment report for the period of custody including treatment given as indoor patient.
- (iv) Inquest report.
 - (v) Post mortem examination report.
- (vi) Videography of post mortem examination.
- (vii) Chemical examination report of viscera.
- (viii) Report with final cause of death based on scientific report.
- (ix) Magisterial inquiry report in details of the case.

The reports should be sent to the Commission within four weeks from today.

A copy of this order may be sent to the National Human Rights Commission, New Delhi with an intimation that cognizance has been taken today by this Commission in respect of the death of U.T. prisoner, Kailash Roy.
