with Biplab went to West Agartala Women PS. There officer-in-charge of the PS threatened the complainant saying that if Biplab did not accept Tanu as wife, then a rape case would be instituted against him and he would be imprisoned for 20 years. The said police officer also utters that a female now a days can marry 4 to 5 times and that is not illegal.

Since it is alleged that police officers have threatened the complainant & Biplab to accept Tanu as wife, though she is found already a married women and insisted the complainant to accept Tanu as wife of Biplab, the Commission considers that their human rights have been violated by O/C West Agartala Women P.S.

On perusal of the complaint, before taking cognizance in this matter, the Commission thinks it appropriate to have a report on the matter from the office of the DGP, Tripura.

Accordingly, DGP Tripura is asked to submit a report in the matter by the next date.

Copy of the complaint along with the copies of enclosed documents may also be sent to the DGP Tripura for ready reference.

List the matter after 3(three) weeks.

Fix it on 26/08/2025 for report of the DGP, Tripura.
