		The news item published in said news papers speaks for	
		itself. The fact remains that an accident took place on	
		Assam Agartala main road, near Chakmaghat area at the	
		dead of night at about 02:30 AM, on Tuesday near TSR	
		Camp at Chakmaghat under Teliamura Police Station.	
		One truck, bearing No. AS01LC5102, loaded with cement	
		was proceeding towards Agartala from Lansang met with	
		an accident at that place pinning its driver Mihir Lal	
		Debnath, who was also the owner of the vehicle in the	
		cabin of the Truck. His leg was crushed and struck inside	
		the cabin, but he was alive, fully conscious, and he was	
		screaming for help for over seven hours. He begged to be	
		rescued. But his voice did not reach the ear of the helping	
		local people. Death was slowly casting shadows in his	
		eyes. The entire incident shows the sheer criminal	
		negligence, inaction and incompetence of Disaster

management authority of Tripura, District Administration, State Police, Fire Service and Civil Defence.

For about seven hours he begged to be rescued. The Disaster Management Department failed to show up even with basic functioning equipments. 2/3 persons came from Disaster Management team, but they were woefully unequipped. They came with 2 wood cutting chainsaws, which were not an equipments to cut open the cabin of the truck. But those chainsaws also did not function properly. The fire service which arrived first virtually confined their work to unload the cement from the truck. They could not do anything else to start the rescue. They were neither trained nor have any equipment nor did they have any idea as to how they should proceed the rescue process.

The Apadamitras and civil defence were missing in action. There were no ambulance, no medical response team so as to offer immediate life saving support to the victim and to transport him to hospital after rescue. The authorities concerned apparently failed to provide any life support mechanism to save the life of the driver of the Truck. There were no senior or trained persons under whose command the rescue operation could be conducted. There was no adequate police arrangement. Those who gathered there, were helpless, clueless, and bare handed and they did not know what to do. They were found confused and shocked.

NDRF, who were trained and well equipped were not called. Only some TSR personnel came but could not do anything. One Administrative Officer reached the site

seven hours later, after Mihir had already expired and by then it was only to recover the dead body.

This shows the clear violation of human rights in the State of Tripura due to inaction of Disaster Management Authority, District Administration, Police Department, Fire Service, and Civil Defense. Accordingly, this Commission has taken cognizance of this incident.

The Commission thinks it appropriate to send the paper cuttings of the news item to the DM & Collector, Khowai District, The Superintendent of Police, Khowai District, the Fire and Emergency Services, Govt. of Tripura for their ready reference.

Issue notice upon those authorities to submit a report separately after due inquiry within 15 days from the date of receipt of the notice.

List the matter on 27.08.2025 for report of the DM & Collector, Khowai District, the Superintendent of Police, Khowai District, the Fire and Emergency Services, Govt. of Tripura.
