Antara Datta, DME, O/o the CMO (W), Agartala visited Katlamara PHC on 21-06-2025 at 11.00 A.M. and interviewed Dr. Nilakshi Debbarma, Medical Officer, Katlamara PHC, Tripura West. A statement regarding the incident is attached herewith for your kind consideration". That report also enclosed the statement of Dr. Nilakshi Debbarma.

The Commission has asked for independent inquiry by Secretary but the committee only relied a statement made by the alleged offending doctor. The commission has taken it as exception that without proper inquiry the Secretary Health & Family Welfare has submitted a report basing on the statements of accused Medical Officer. This being the position no reliance can be made on the report of the Secretary. So, the Commission thinks it appropriate to get the matter enquired through the investigating wing of this commission.

Accordingly, the Investigation Wing of the THRC is asked to make a detailed inquiry regarding the fact in issue and to submit a report before this Commission. Copy of this order shall be
