communication is made by the Joint Secretary & Director of Urban Development Department, Miss. Megha Jain, IAS, enclosing some documents and on behalf of that department, Mr. Amitabha Chakma, Joint Director is physically present.

On behalf of the Revenue Department, Mr. Subrata Datta, Joint Secretary, Govt. of Tripura appears and submits a good numbers of documents by one forwarding without any firisti. He submits total 134 sheets of documents. Keep them with the record.

Mr. Datta has made it clear that he has submitted as many as 134 sheets of documents all relating to Education Department covering M.B.B College and lake in respect of both the settlement operations and subsequent period. Mr. Datta has clearly stated that as per official record there is no existence of Bidya Pattan. He submits that some more documents may be available under Director of Land Records & Settlement, under Revenue Department and he is ready to consult those documents. Thereafter he can only submit a concrete report.

Mr. Akshay Bhorde, DFO, has assured this Commission that he will arrange for local inspection of the area and thereafter he will submit a details report whether there is any violation of existing rules and laws regarding bio-diversity.

Today, the complainant again has submit another petition praying to consolidate and treat the petition as an integral part of the complaint i.e the complaint No. 98 of 2025. Keep it with the record.

Copy of this petition shall be supplied to all concerned including the Secretary, Revenue Department, Principal Secretary, Forest Department, the Secretary, Urban Development Department, the Chairperson Tripura State

Pollution Control Board, the Secretary Agartala Smart City limited and the Secretary, Higher Education Department. It is further directed that the Land Records & settlement and Revenue Department shall furnish a report as regards the present status of entire area and whether there is any illegal encroachment in and around the land in question and the lake as well.

With the aforesaid direction, the case is adjourned today.

Let the case be fixed after 3 weeks for step by the respective departments.

The complainant is asked to ensure that copies of the present complaint can be supplied to those departments within 2 days.
