BLN PS approximately 14 to 15 km away from her home. It was already at night and there were no houses nearby that plantation and at that spot three more boys were present and there the five boys committed rape upon the victim and next day that is on 14/12/2024, at the morning at about 4.30 PM, the victim was dropped near Holy Cross School not far from her residence. Reaching at home, she disclosed all the facts to her guardian. The guardian of the victim lodged a complaint at Santirbazar PS on 14/12/2024. Accordingly, police also registered a case bearing No. 2024STB033 u/s 70(2)/96 of BBS and also u/s 6 of the POCSO Act. Inspector Jayanta Das, being O/C, Manpathar OP was the first IO investigated the case. Thereafter, Inspector Sipra Chanda of Belonia PS completed investigation as per order of SP, South. All the FIR named accused were arrested by IO. All the FIR named A/Ps are aged about 18 and above. During investigation, medical examination of the victim girl was arranged. Medical examination of the accused person was also done and collected the medical reports of the victim. The Medical Officer Dr. Shrabanti Bhowmik opined that victim that no injury mark was seen over the body except one bruise over right upper shoulder. The hymen was found



ruptured, bruise was over the right upper shoulder and there was evidence of sexual assault. The medical reports of all the A/Ps show that all the A/Ps are capable of sexual intercourse. It is also reported that the victim belongs to a very poor family and her guardian had to sell their pigs and borrow money from the relatives for the purpose of her treatment. The family already incurred expenditure of Rs. 1 lac for her treatment. So, in the report of Investigation Wing, the allegation of sexual assault on the victim prima facie supported showing her family status. These being the position.
