A copy of the suggestions is also enclosed by the Tripura State Pollution Control Board. Copy of the report be supplied to the complainant. Also received one report from Dr. Shailesh Kumar Yadav, being CEO, Agartala Smart City Limited. Also received another communication from Dr. Vishal Kumar, IAS being D.M & Collector wherein he mentioned following:

- i. "No any unlawful land filling and encroachment of water body has taken place
- ii. Some concrete pillars and construction has been done in the water body by the Agartala Smart City Limited.
- iii. There is no any information/document in connection with Arbitrary land allotment (Touji) over a public water body done by the AMC".

Also supply copy of the report of the D.M. & Collector to the complainant for his response. On behalf of the Agartala Municipal Corporation, Municipal Commissioner has submitted a detailed report enclosing some document s including copy of judgment of Hon'ble High Court in respect of 10

On behalf of Secretary, Revenue Department, a petition is filed by the Under Secretary, Govt. of Tripura praying for extension of time for 14(fourteen) days. Consider the prayer.
