Hospital, Bishalgarh declared him as brought dead on the same day at about 06.05 A.M. Accordingly, Medical Officer, Bishalgarh Sub-Divisional Hospital requested the O/C, Bishalgarh PS to shift the dead body to AGMC for conducting postmortem examination and also to confirm that information to be given to the family members and near relatives of the deceased with a request to the family members to attend AGMC and GBP Hospital for receiving the dead body after observing necessary formalities.

Since it was a death while a U.T. prisoner was in custody, this Commission registered this case to see cause of death and circumstances under which the death was resulted and accordingly cognizance of the incident was taken on the basis of the papers placed to the Commission for further course of action.

The Inspector General of Prisons, Tripura was therefore, directed to furnish some particulars which includes detailed report covering all aspects leading to death of the prisoner, initial health screening report, complete medical treatment report, copy of Inquest report, copy of Postmortem report, Videography of postmortem examination, chemical examination report of viscera, Magisterial Inquiry report and report in respect of final cause of death. After the case was registered on 30/06/2025,



subsequently receive a complaint from Shri Sudip Sarkar, Member, Tripura Legislative Assembly to initiate a suitable action connection with THRC case No.92/2025 that is in connection with the present case. Since the Commission already undertaken an enquiry regarding the death of U.T. prisoner, the petition of the MLA, Mr. Sudip Sarkar be tagged with the record.

Today received a report from IG (Prisons) by which copy of the Inquest report and Postmortem report has been furnished and it is mentioned that Chemical examination report of viscera and final cause of death based on SFSL report and Magisterial inquiry report will be submitted as and when those documents will be received by IG (Prisons). Also received some communication which was addressed to D.M. & Collector by IG (Prisons) requesting him to furnish the copy of the Magisterial inquiry report copy to this Commission and another with communication addressed to Superintendant of Police, Sepahijala with request to furnish chemical examination report of viscera in respect of final cause of death based on scientific report with copies to this Commission. Keep those documents with the record.

On perusal of the record, it is clear that initial information was also addressed to National

Human Rights Commission. So, it is the duty of this Commission to inform the National Human Rights Commission that this Commission have already started an enquiry in respect of custodial death of U.T. prisoner. Already order was passed in this respect. If it is not sent than information in this regard be again given to National Human Rights Commission. Fix the next date for submission of report by IG(Prisons).
