		had the attention of the Chairperson, Tripura Human	
		Rights Commission, mentioning that during	
		celebration of Ganesh Chaturthi and Biswarjan of	
		God Ganesha, the excessive of highly complexed	
		sound system leads to serious disruption of peaceful	
		sleep and mental agony. As a result the physical and	
		mental health of the complainant and others are	
		adversely affected and amounts to serious violation of	
		their fundamental right and human rights and he	
		prayed to the Commission to take cognizance of those	
		facts and to ensure protection of their human rights.	
		It has come to the notice of the Commission that	
		many clubs or organizers celebrated Ganesh	
		Chaturthi. They also organized processions	
		throughout the important streets of the city viz Hari	
	B	Ganga Basak road, Akhawra road, Jagannath Bari	
-		Road and many other important streets of Agartala. It	
		is noticed that processions were under taken with	
		high decibel sound boxes/ musical instruments. It is	
		also reported in many news papers that law enforcing	

agencies, especially, the West Agartala and the East Agartala Police Stations tried to prevent and restrict the noise pollutions requesting the organizers to reduce the volume of such musical instruments. But, some of the club members or members organizations challenged the authorities of the law enforcing agencies to prevent them from making sound/noise pollution. It is also reported that some members of the organization conducting precessions even threatened the police officials while performing their official duties with dire consequences.

The Commission has taken serious note of such incident.

Right to health and adequate medical services and care are fundamental rights of a citizen under article 21 of the constitution of India. Right to adequate and peaceful sleep directly relates to right to health and medical care. To say the least, right to health is a integral facet of article 21 of Constitution of India. IGM hospital and may other nursing homes are situated in the heart of the city of Agartala. Similar situation is noticed in and around the AGMC & GBP hospital, Agartala. Such precessions and the sounds of musical instruments with high volume badly affect the city dwellers and especially the patients of IGM hospitals, the patients of nursing homes, as well as the patients admitted at AGMC &GBP hospitals, Agartala. That apart there are so many old aged citizens who have the right to sleep peacefully are badly affected due to such noise/sound

pollution. The Hon'ble Supreme court of India as well as the High Court of Tripura already had passed directions in their judgments prohibiting sound pollution in and around the hospital/nursing homes as well, cautioned such organizers and clubs not to disturb the peaceful sleeps of the citizens. Further, such noise/sound pollution directly disturb the peaceful study of the students.

The use of high volume mechanical sound system had caused serious disturbances to the public peace, adversely affect the rights of the citizens to leave in a peaceful and pollution free environment which forms an integral part of right to life guaranteed on the article 21 of the Constitution of India. The loud speakers and DJ sound beyond permissible limit prescribes under Noise Pollution (Regulation and Control) Rules 2020 amounts to a violation of citizens fundamental rights. Thus, the Commission thinks it appropriate to issue notice upon the Secretary, Tripura State Pollution Control Board, the DM & Collector, West Tripura, Agartala and the Superintendent of Police, West Tripura to personally appear before the Commission on 02.09.2025 at 11:30 A.M Sto apprise the Commission about the steps and measures they have taken to prevent such violation.
