		stated in the complaint that she and other Members	
		of the family have been possessing the land	
		peacefully since their predecessors. The	
		Complainant also has stated that they have filed a	
		Revenue case vide No. 05/ 2025 for correction of	
		records but till today no hearing of the matter is	
		taken place, and taking the said advantage, the	
		Tehsildar along with other Government officials have	
		not submitted any enquiry report and thus have

been harassing the complainant. According to the complainant, she lodged FIR in the office of the Superintendent of Police, West Tripura and Officer-in-charge, Barjala Police Station, but they did not take any action till today.

It is further stated that the Complainant belongs to a member of backward community. The opposite parties i.e. Banti Deb and his other companions have been constantly threatening the complainant with dire consequences.

Since the complainant Smt. Anita Bin has not been able to get any redress from the Government Officials, she has approached to this Commission alleging violation of human rights as she along with her family members are subjected to severe harassment, and being deprived of her constitutional right to property as encapsulated under Article 300 - A of the Constitution of India.

The Commission has considered the prayer and the grievances agitated in the complaint by the complainant, Smt. Anita Bin and *prima facie* finds merit in the complaint.

Accordingly, the Commission has taken cognizance of the complaint.

Issue notice upon the opposite parties against

whom the complaint has been lodged including the Superintendent of Police, West Tripura, Officer-in-Charge, Barjala, Police Station, Sadar, DCM, Barjala Revenue Circle, Sadar, Tehsildar, Lankamura T.K. to Show-cause as to why the complainant would not get redress from the grievances agitated in the instant complaint.

Notice is returnable within 3(three) weeks after receipt of the same by the concerned person.
