Since, all the complaints relate to the same issues, no separate case need to be registered in respect of their cases and all the cases be tagged with the present complaint. Since, the name of Bikash Sarkar has not yet transpired in the report of the Investigation Wing, notice be issued to him to appear before this Commission in connection</p>
