		taking tiffin in 'Joyram Varieties', a shop of one	
		Subal Saha near TV Tower, A.D. Nagar. After taking	
a		tiffin, he gave Rs. 50/- to the shop owner and asked	
		him to pay back Rs. 30/- deducting Rs.20/- towards	
		the cost of tiffin. But Sankari Saha, W/o Subal Saha	
		and other women assaulted him in front of the shop.	

The matter was noted in GDE No.26 of A.D. Nagar PS dated 22/08/2025.

Based on the verbal complaint, ASI Jatindra Debbarma of A.D. Nagar PS enquired into the matter and it surfaced that on 22/08/2025 morning, the complainant Shri Pritam Choudhury, a casual worker of Agartala Municipal Corporation (AMC) was taking tiffin in the shop of Subal Saha where some women workers of AMC were also there. After taking tiffin, Shri Pritam Chowdhury gave Rs.50/- to the shop owner and asked him to return Rs.30/- . He squeezed the used paper packet of tiffin and threw it towards the dustbin but it hit a woman namely Smt. Sobha Rani Debnath, who was sitting in the shop. She was annoyed and asked Pritam Chowdhury as to why he had thrown it on her body. With that there was an altercation between Pritam Chowdhury and the women in the shop. Pritam Chowdhury was so irritated that he took out his slippers and tried to assault the women workers of AMC. The shop owner Subal Saha and his wife tried to stop them but Pritam Chowdhury also misbehaved with them. Subsequently, on duty Emergency Response Support System (ERSS) team rushed to the spot and stopped their argument and quarrel. It is stated that the shop Subal Saha returned Rs. 30/-Pritam

Chowdhury in front of the said team.

ASI Jatindra Debbarma submitted Prosecution Report u/s 126 BNSS against both parties. It is denied that Shri Sushanta Deb, Officer-in-Charge of A.D. Nagar PS misbehaved and assaulted the complainant. The medical report submitted by the complainant Pritam Chowdhury was dated 27/08/2025 i.e. 05 days after the incident. No external injury was found on his body by the attending medical officer. Thus the allegation of the complainant was found baseless and false.

This being the position, the Commission thinks it appropriate to send the copy of the DGP, Tripura to the complainant for his response against the report of the DGP, Tripura, if any.
