		Officer, National Human Rights Commission,	
		Tripura Human Rights Commission, Secretary,	
		Labour Department, DGP, Tripura etc.	
		Allegation was basically labeled alleging	
		negligence exploitation in respect of innocent tribal	
		construction labour in Agartala namely Mr. Amirlin	
	,	Halam, aged about 24 years of Uttar Patharkandi,	
		Karimganj District, Assam. The location of work is a	

residential flat construction site at Ramnagar Road No.1 near park opposite of Joyram Kutir, Agartala. It is alleged that while working on third floor, Amirlin Halam fell from height and suffered serious waist and bone injuries. The contractor and site manager did not take him to hospital and instead gave him only Rs.800/- and ordered him to go alone. He somehow walked in pain to IGM Hospital which was situated about one and half kilometer away and they forced him to lie to the doctor instructing him to say that he slipped in the bathroom. The hospital x-ray revealed serious bone gap in the waist requiring long term treatment. The complainant approached the contractor Mr. Rubel Khan but Rubel Khan refused to give any money with acclaim that he already paid Rs.1300/- The contractor refused to disclose the owner and manager details.

As per Rule 9 of Tripura Human Rights Commission Regulation, 2022, the Commission may consider to dismiss in limine the complete, if the complaint is addressed to some other authority and the copy is received by this Commission. Since the Commission is given only one copy of the complaint which is addressed to some other authority, the Commission should not take cognizance of the matter because Labour Commissioner i.e. the

addressee may take action on the basis of the complaint by the complainant. So, on the basis of the present complaint, the Commission cannot proceed further as per Rule 9 of Tripura Human Rights Commission Regulation, 2022. Accordingly, cognizance is not taken on the complaint. Complaint be filed and information be given to the complainant through his E-mail.
