13/12/2024 and on 15/12/2024, his condition became serious. He was admitted to IGM Hospital and from there he was shifted to Agartala GBP Hospital. Subsequently it was found that blood was clot in his head. He was admitted to GB on 16/12/2024. Due to lack of beds in that hospital, he was admitted to ILS Hospital and operation was performed on 17/12/2024 at around 10 PM. Later his brother was again admitted to GBP & AGMC Hospital and during the treatment, he died on 07/01/2025 at about 4-4:30 AM.

The alleged motor accident took place near Gokulpur, Shastriji Sangha and name of the elder brother was Suman Paul. The complainant was busy of brother treatment his medical with subsequently also he remained busy for Shraddha submitted a written work. The complainant complaint that he approached to the OC, R.K. Pur PS with written complaint claiming the death of the deceased as a result of the said road accident . It appears that complainant wanted to say that the death of the deceased was due to rash and negligent driving of the involved auto. But the O/C had refused to register the complaint or to take any lawful action u/s 154 of the criminal procedure. He also submitted representation before the Supdt. of Police, Gomati District on 02/09/2025. Till today no action was taken.

Accordingly, this complaint was filed due to inaction of the police authority by refusing to register FIR on the basis of the complaint.

Before taking cognizance of the case, the Commission deems it necessary to obtain a report from the office of the DGP, Tripura on the allegation of the complainant. Send a copy of the complaint to the DGP, Tripura with a request to submit a report on the allegation of the complainant.

Let the case be fixed after 3(three) weeks.

List it on 1310 2025 for report of the DGP, Tripura.
