The video shows an old person probably belonging to the impoverished sections of the society being dragged out of a ward by some staff members and then being laid down on the floor. The helpless women can be seen crying for help but help does not come at all. The visuals are quite pathetic and hard for anyone to see. Such an ill treatment is totally unacceptable in a civilized society and it is, therefore, a violation of human rights and also violation of Article 21 of Constitution of India. Therefore, it is a matter which falls under the scope investigation by Tripura Human Rights Commission.

It is also mentioned that Govind Ballabh Pant Hospital is one of the best medical treatment and health care institution in Tripura and has acted life line of the city. Such an incident in the premises of Govind Balabh Pant hospital must draw attention of concerned authorized authorities as it highlights a humongous problem of mismanagement of the authority of the hospital and ill treatment towards specific citizens in such governmental bodies. The complaint speaks itself. The complainants have submitted their Aadhaar card also and photographs of the ill fagted old lady.



This being the position before taking cognizance of the matter, The Commissions thinks it appropriate to obtain a report from the Director, Health & Family Welfare, Govt. of Tripura. The report of the Director, Health & Family Welfare Department, Govt. of Tripura should reach to this Commission positively within 3(three) weeks. List the case after 3(three) weeks. Information in this regard be given to the complainants.
