they already submitted a written statement. The General Manager prayed to be exempted from his personal appearance and always wanted to be represented by his counsel and accordingly General Manager was exempted to appear personally. But it appears that the land was acquired for the purpose of the road as per requisition of the NHIDCL.

So, NHIDCL is legally bound to make payment. The condition as imposed by the NHIDCL that when they will initiate proposal for payment of compensation after they initiate preparation of road cannot be accepted by the Commission. The NHIDCL is asked to initiate the process of payment of acquired land within 1(one) month failing which the Commission would proceed to pass its recommendation which may affect the particular officers of the NHIDCL who are responsible for non-payment of compensation for the acquired lands.

The Commission expects that the NHIDCL shall take necessary steps to implement this order within 1(one) month and intimate this Commission about their action. No further chance will be given to the NHIDCL.

So, fix the next date for implementation of this order by the NHIDCL and fix the next date after 1(one) month for step by the NHIDCL. Silence on

behalf of the NHIDCL shall be treated as intentional disobedience of this order and the case will be fixed for final recommendation.

Accordingly, inform NHIDCL and District Magistrate & Collector, North Tripura.
