Today, Shri Atnu Chakraborty, DFO, Sepahijala District and Shri Chandan Sarkar, SDFO, Sonamura is physically present to assist this Commission about their action and to clarify the report as submitted by them.

It is mentioned in the report that receiving newspaper publication the department already visited the place of occurrence and an enquiry have been conducted.

Some illicit felling of trees were detected in Bejimara under Sonamura Sub-Division. Approx. 60 Nos. stamp were seized by Beat Officer, Sonamura and 4(four) accused persons were involved in that illicit felling. Accordingly, The Forest Department filed an FIR with Sonamura PS and also launched prosecution against 4(four) persons namely (1) Shri Bishu Paul, S/O Late Birendra Paul, (2) Shri Nirmal Paul, S/O Bala Paul, (3) Shri Parimal Paul, S/O Late Bala Paul and against Shri Gopal Paul, S/O Late Jadab Paul.

On the basis of the complaint, a complaint case was registered bearing No.CR(F) 03 of 2025 u/s 274 of BNSS.

It is also stated that for prevention of repetition of this kind of incident, a proposal was



initiated by the Sonamura Sub-Divisional Forest Officer for causing boundary fencing of that area through barbed wire and the matter is under active consideration of the authority. Presently, bamboo fencing have been arranged to prevent any further attempt of stealing of plants. Besides, some other essential measures have also been taken and to prevent this kind of activities. Continuous monitoring of the area are being maintained.

On perusal of the report, it appears that the department has already initiated due action and measures for prevention this kind of activities.

Thus, this Commission considers that the Commission need not proceed further and this case should be disposed of since due action has already taken by the department.
